Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible . The total family deductible is met by the combination of all family members meeting their individual deductible.
Are there services covered before you meet your deductible ?	No.	You will have to meet the deductible before the plan pays for any services.
