What is the overall deductible ?	\$2,500 /single or \$5,000 /family for In- Network Providers . \$5,000 /single or \$10,000 /family for Non- Network Providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you select family membership, No individual deductible applies and the family deductible must be met. In-Network Provider and Non-Network Provider deductibles are separate and do not count towards each other.
Are there services covered before you meet your deductible ?	Yes. Preventive care for In- Network Providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	\$5,000 /single or \$6,850 /family for In- Network Providers . \$10,000 /single or 20,000 /family for Non- Network Providers .	The out-of-pocket limit is the most you could pay in a year for covered services. If you select family membership, No individual out-of-pocket annual maximum applies and the family out-of-pocket annual maximum must be met.
What is not included in the out-of-pocket limit ?	Pre-Authorization Penalties, Premiums , balance-billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
