What is the overall deductible ?	\$0 /single or \$0 /family for In- Network Providers . \$2,000 /single or \$6,000 /family for Non- Network Providers .	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible . The total family deductible is met by the combination of all family members meeting their individual deductible.
Are there services covered before you meet your deductible ?	Yes. Preventive care for In- Network Providers .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	Yes. There is a separate outpatient \$50 deductible for prescription drugs for each member.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	\$3,500 /single or \$9,000 /family for In- Network Providers . \$8,000 /single or \$24,000 /family for Non- Network Providers .	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits .
