What is the overall <a href="#">deductible</a> ?	<b>\$1,500</b> /single or <b>\$3,000</b> /family for In- <a href="#">Network Providers</a> . <b>\$3,000</b> /single or <b>\$6,000</b> /family for Non- <a href="#">Network Providers</a> .	Generally, you must pay all of the costs from <a href="#">providers</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> . The total family deductible is met by the combination of all family members meeting their individual deductible.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes. <a href="#">Preventive care</a> for In- <a href="#">Network Providers</a> .
